





What is the *Indian*Boarding Homes Class Action?



About the Indian Boarding Homes "IBHP" Class Action

- Canada created the Indian Boarding Homes Program in the 1950s which removed First Nations
 and Inuit children from their communities and placed them in private homes for the purpose of
 attending school.
- The Indian Boarding Homes Class Action provides compensation to people placed in these homes.
- Primary Class Members are individuals who were placed in private homes, during the period of September 1, 1951 and June 30, 1992, for the purpose of attending school, not including placements for post-secondary education. Individuals placed after June 30, 1992, are also included if Canada was responsible for their placement.

Why should I file a claim?

- People that file claims in the Indian Boarding Homes Class Action and found to be eligible, can receive financial compensation.
- There are two types of claims:

Category 1 – Claim for placement in the Indian Boarding Homes Program

- This category of claim provides compensation for placement in the Indian Boarding Homes Program.
- The amount of compensation for these claims is \$10,000.

Category 2 - Claim for abuse

- This category of claim provides compensation based on the harm that was suffered by the person placed in the Indian Boarding Homes program.
- The amount of compensation will be in line with the "compensation grid" provided in the Settlement
 agreement. It is dependent on the harm suffered by the Class Member and ranges from \$10,000 to \$200,000.
- **IMPORTANT:** Filing a Category 2 claim is **optional.** You do not have to complete a form if you only want to make a Category 1 claim.



Who is eligible to make a claim in the IBHP Class Action?

Individuals are eligible to make a claim if:

- 1. They were placed in a **private home for the purpose of attending school** (primary, or secondary school only) **AND**
- 2. They were placed in this **private home during the period between September 1, 1951 and June 30, 1992** *OR*
- 3. They were placed **after June 30, 1992** and the **Government of Canada was responsible for their placement** *AND*
- 4. They were alive on or after July 24, 2016 OR
- 5. They represent the estate of someone who met the above criteria, and has since passed away.



How can I check if I am eligible to make a claim?

Am I eligible if I took part in a previous class action?

Class Members may still be eligible even if they participated in previous class actions.

Examples of previous class actions include:

Residential Schools Class Action:

For Indigenous children placed in government funded institutions where they stayed away from home for months or years.

Day Schools Class Action

For Indigenous children placed in government-funded schools during the day without staying overnight.

Sixties Scoop Class Action

For Indigenous children who were taken from their families adopted by non-Indigenous families or placed in non-Indigenous families for permanent care.

Who can file a claim form?

- There are 3 claim forms that can be completed by the different types of people that can act as a *claimant*. A claimant is someone who files a claim.
- The 3 different types of people that can act as a claimant are:
 - **Primary Class Member** A person who is making a **claim on their own behalf**. They are making a claim that they were placed in the Indian Boarding Homes Program, and potentially experienced harm as part of the program.
 - **Personal Representative** A person who is making a **claim on a class member's behalf**. They are representing the class member because **the class member is considered a "Person under disability**" who is "unable to manage or make reasonable judgments or decisions by reason of mental incapacity."
 - **Estate Representative** A person who is making a claim on behalf of a Primary **class member who has passed away.** An Estate representative can be for an "Estate with a will", where the class member designated an executor for their estate before they died, or for an "Estate without a will", where the representative is the "highest priority heir".



- The claims period will formally begin on Wednesday, August 21, 2024
- The claims period will run for ~2 1/2 years and close February 22, 2027

What does this mean?

 Claimants will have to submit their claims (both the Category 1 and Category 2 by this date unless they have an approved extension).





How do I start the claims process?


Understanding the Claims Process

<u>Claim Lifecycle - Per Category Claim</u>

Complete & Send your Claim Form

Administrator reviews your claim

(Optional) Administrator asks the claimant questions if needed



 Administrator sends a confirmation of receipt 4-8 weeks after your claim is received

Receive the results of your claim
6-8 Months*

*Notes:

- The time needed to process your claim will depend on the complexity of the claim and your situation
- Claimants applying for a class member that has passed away, but did not leave a will, will be processed at the close of the claims period on February 22, 2027


